#### **Annual High Cost of Illness**

- ► About 300-400 outbreaks of norovirus are reported to the National Enteric Surveillance Program at the Public Health Agency of Canada each year¹
- ► The flu causes the loss of an estimated 1.5 million workdays each year from absences and reduced productivity, at a total cost in each influenza season estimated to be \$1 billion per year²
- ► The Public Health Agency of Canada estimates that in a given year, there is an average of 12,200 hospitalizations related to influenza in Canada and approximately 3,500 Canadians die of flu each year³
- ► Canada recorded 19,000 cases of RSV in 2019<sup>4</sup>
